- 2. All services and facilities provided by Chinese YMCA of Hong Kong are for members only. Members must present valid physical or e-membership cards before participating in activities, using facilities and services.
- 3. Chinese YMCA of Hong Kong will provide Personal Accident Coverage for members who participate in all Chinese YMCA of Hong Kong activities. The eligibility of coverage is subject to the insurance policy.

 1. Life Members and Supporting Members whose physical membership cards are either lost or damaged can apply for replacement membership cards free of charge through Corporate Communications & Marketing
 Section of Chinese YMCA of Hong Kong, Other members would have to re-apply and pay HK\$10 for a replacement of physical membership card. The validity period for replacement membership cards remains
- unchanged.

 5. Members can renew their membership within six months prior to their membership expiry dates. The effective date will be started from the date of expiry. Members are eligible to apply for a 1-year, 3-year or 5-year membership.
- 6. If members wish to access to or make changes to their personal data, please submit a written request to Chinese YMCA of Hong Kong.
- 7. Any man of the Chinese race who is baptised Christian upon verification by pastor and is 18 years old or above, recommended by the ProtestantVoting Member or Secretary of the Association, can be a Protestant Voting Member. He is eligible to participate in Annual General Meeting and elect directors of Chinese YMCA of Hong Kong (Except Allied School Membership and Group Membership). Please note that applicants must select and apply to become a Protestant Voting Member, and fill in either the date of baptism or the name of baptising pastor in the membership application form. Please submit the certificate of baptised church and affiliated church on or before 10th May of that year. If member does not apply for or cannot become a Protestant Voting Member, it will not affect the identity and rights of being a member.
- 8. Each member is entitled for only one valid membership at one time. If a member is holding more than one membership at the same time, Chinese YMCA of Hong Kong has the right to terminate the additional membership without prior notice to the member.
